Studio policy

1: Billing obligation:

- Class fees:

1 Class per week per month: R300.00

- 2 – 4 Classes per week per month: R280.00
- 5 and more classes per week per month: R250.00
- Dance Fitness: R400 per month; 2 classes a week.
- Dance Fitness: R500 per month; 3 classes a week.
- Body Shape: R400 per month; 2 classes a week.
- Body Shape: R500 per month; 3 classes a week.
- Stretch classes: R45 per class / R180 per month.
- Body Shape one-on-one: R450 – R600 per month; 1 – 3 classes a week.
 - Payable monthly (before the 7th of every month).
- Payable 3 months in advance (before the 7th of every 3month).
- Payable 6 months in advance before the 7th of every 6month).
 - Payment: 12months a year.
 - Cancellation: 1 month in advance.
- Private and individual competition classes: R150 an hour.



- Payable monthly (before the 7th of every month).
- Payable 3 months in advance (before the 7th of every 3rd month).
- Payable 6 months in advance (before the 7th of every 6th month).
- Payment: 12months a year.
- Cancellation: 1 month in advance.

- Private and individual competition classes: R150 an hour.
 - Fees must be payed by the 7th of every month.
 - Failure to pay fees 2 consecutive months will result in termination of classes.
 - Dance fees must be payed 12months a year. (which includes Decembers)
 - EFT or Cash payments are aloud.
 - There are no refunds once a pupil was enrolled at Memphis Move Dance Studio.

2: Risks related to dance:

Memphis Move Dance Studio cannot be held responsible for any injuries that occur to a dancer or person on the Memphis Move Dance Studio's property or in the dance studio. MMDS will phone parents/guardian and have permission to take necessary steps in case of an injury. Dancers are motivated to be 10min before class starts at the studio to do a pre-warmup, to prevent injury from happening. Medical illness or any medical information about a dancer; must be reported/disclosed to MMDS.

3: Dress code

Dancers must always dress in appropriated dancing attire. Long hair must be tied up and out of the dancer's face. No 'see-through' cloths and all 'bikini-areas' should be covered properly.

- With technical dance styles dancers will wear clothing in line with dress code communicated to them.
- Hip Hop dancers wear tekkies.
- Dancers are responsible for their own dance uniforms.

4: Media rights permission:

MMDS have permission to use all, and any footage taken of dancers, during class and competitions, on social media - Weather it is for advertising or any other reason. Photos and videos of dancers might still be used even if a dancer left MMDS. In line with new POPIA act parents need to give clear consent for any rights to use dancer media on social media platforms.

5: Attendance policy:

Dancers must attend as much classes as possible. MMDS will not be responsible for classes that the dancers missed and need not have a 'catch-up' class. If a dancer is sick or cannot make a dance class MMDS must be informed at leased 30min prior to the class. MMDS teachers have the responsibility to wait 15 min into a class before disclosing that the dancer will not show up for class.

- During school holidays and public holidays, MMDS will be closed.
- 1 Months' payed notice is required if a dancer cancels dancing lessons.
- If a MMDS teacher could not make a class – 2hour prior to class parent/dancers need to be informed.

- Classes may need to be taught by a student teacher or substitute teacher if the designated teacher is sick/away on business/holiday etc. without notice.
- Catch-up classes will be scheduled by the teacher if a class is canceled by her/him.
- Dancers must be at class 10min before class start on order to start a pre-warmup on their own. This will help to prevent injuries.
- No parents are aloud in the studio during class time.
- Right of admission to classes is reserved and if for any reason (such as misbehavior) a child is asked to leave a class by a teacher, this is to be accepted without any refund of fees paid.

6: Responsibilities of property:

- Dancers take responsibility for their own property. MMDS will not take responsibility for any property stolen or broken at the Studio or even on the Memphis Move Dance Studio's facilities.
- MMDS property broken and damaged by dancers will need to be replaced by the specific party.

7: Schedule:

The dance schedule is very important to follow. Dancers need to be at studio 10min prior to their class for a pre-warmup. Dancers cannot join other classes then their own. There is a 15min break between each class, if a parent/dancer has any questions they can speak to MMDS teacher then.

- Hoppers and RazzMatazz classes are 30min long.
- Regular classes are 45min long.
- Adults and advance classes are 60min long.

The class schedules might change every year or as classes grow in number of students. Please remember that no parents are allowed in the studio during class times. Unfortunately, class times cannot be changed for a dancer and the times scheduled for specific style and ages is semi-permanent. Dancers and parents are responsible for their own transport to and from the studio and teachers are not responsible for taking care of dancers while they wait for transport.

8: Additional info:

- Some of the teachers at Memphis Move Dance Studio might be professional dancers/choreographers and will from time-to-time book another dances related work. This should be seen as a privilege by parents and pupils, as professional work done by their teachers opens new networking possibilities for the pupil's potential dance careers. In such instances substitute teachers/student teachers may teach classes as stated above.

- If a class is to take part in performances/exams/shows, it is the teacher's discretion whether each pupil is performance ready and whether to include him/her in the event.

- Pupils are expected to practice at home and know the work learnt in class, and to wear the prescribed uniform for classes and costumes for shows. These will be additional expenses, above and beyond the monthly tuition fees.
- There will be exams for the Jazz and Hip-Hop students and a concert at the end of the year and all pupils are expected to participate.
- Pupils are to get permission to attend any outside workshops/events in case of conflict of interest.

If I do not want photos and videos taken and used for advertisement and other, of dancer; MMDS is informed of my choice. I confirm that I am the parent or legal guardian and am mandated to waiver rights in terms of this agreement. I further confirm that I have read, understood and agree to be bound by the above clause.
